EURO AREA SECURITIES ISSUES STATISTICS: JUNE 2014

The annual rate of change of the [outstanding amount of debt securities](#) issued by euro area residents was -0.6% in June 2014, compared with -0.7% in May. For the [outstanding amount of quoted shares](#) issued by euro area residents, the annual growth rate decreased from 1.7% in May 2014 to 1.2% in June.

[New issuance](#) of debt securities by euro area residents totalled EUR 608 billion in June 2014. [Redemptions](#) stood at EUR 657 billion and [net issues](#) amounted to EUR -47 billion.¹ The annual rate of change of [outstanding debt securities](#) issued by euro area residents was -0.6% in June 2014, compared with -0.7% in May (see Table 1 and Charts 1 and 3).

The annual rate of change of outstanding [short-term debt securities](#) was -9.7% in June 2014, compared with -10.2% in May. For [long-term debt securities](#), the annual growth rate was 0.3% in June 2014, compared with 0.2% in May. The annual growth rate of outstanding [fixed rate long-term debt securities](#) was 2.2% in June 2014, the same as in May. The annual rate of change of outstanding [variable rate long-term debt securities](#) was -5.5% in June 2014, compared with -5.4% in May (see Table 1 and Chart 3).

As regards the sectoral breakdown, the annual growth rate of outstanding [debt securities issued by non-financial corporations](#) increased from 8.0% in May 2014 to 8.6% in June. For the [monetary financial institutions \(MFIs\)](#) sector, this rate of change was -7.3% in June 2014, compared with -7.1% in May. The annual rate of change of outstanding debt securities issued by [financial corporations other than MFIs](#) decreased from -2.1% in May 2014 to -2.6% in June. For the [general government](#), this growth rate increased from 3.3% in May 2014 to 3.7% in June (see Table 2 and Chart 4).

The annual rate of change of outstanding [short-term debt securities issued by MFIs](#) was -7.8% in June 2014, compared with -9.0% in May. The annual rate of change of outstanding [long-term debt securities issued by MFIs](#) decreased from -6.8% in May 2014 to -7.2% in June (see Table 2).

Concerning the currency breakdown, the annual rate of change of outstanding [euro-denominated debt securities](#) was -1.0% in June 2014, the same as in May. For [debt securities in other currencies](#), this growth rate increased from 1.5% in May 2014 to 2.4% in June (see Table 1).

¹ As a full breakdown of net issues into gross issues and redemptions is not available due to missing data, the difference between aggregated gross issues and redemptions may deviate from the aggregated net issues.

[New issuance](#) of quoted shares by euro area residents totalled EUR 22.5 billion in June 2014. [Redemptions](#) came to EUR 1.9 billion and [net issues](#) amounted to EUR 20.6 billion. The annual growth rate of the outstanding amount of [quoted shares issued by euro area residents](#) (excluding valuation changes) decreased from 1.7% in May 2014 to 1.2% in June. The annual growth rate of quoted shares issued by [non-financial corporations](#) was 0.6% in June 2014, the same as in May. For [MFIs](#), the corresponding growth rate decreased from 10.5% in May 2014 to 5.2% in June. For [financial corporations other than MFIs](#), this growth rate increased from 1.8% in May 2014 to 2.9% in June (see Table 4 and Chart 6).

The market value of the [outstanding amount of quoted shares](#) issued by euro area residents totalled EUR 5,952 billion at the end of June 2014. Compared with EUR 4,664 billion at the end of June 2013, this represents an annual increase of 27.6% in the value of the stock of quoted shares in June 2014, up from 22.0% in May.

Unless otherwise indicated, data relate to non-seasonally adjusted statistics. In addition to the developments for June 2014, this press release incorporates minor revisions to the data for previous periods. The annual growth rates are based on financial transactions that occur when an institutional unit incurs or redeems liabilities, they are not affected by the impact of any other changes which do not arise from transactions.



Chart 2: Total net issuance of debt securities by euro area residents


(EUR billions; transactions during the month; nominal values; seasonally adjusted)




Chart 4: Annual growth rates of debt securities issued by euro area residents, by sector


