Consolidated financial statement of the Eurosystem as at 23 March 2018: commentary

In the week ending 23 March 2018 **gold and gold receivables** (asset item 1) decreased by EUR 27 million owing to the sale of gold by one Eurosystem national central bank for the purpose of producing a commemorative coin.

The net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) increased by EUR 0.2 billion to EUR 255.7 billion.

As a result of the Eurosystem's open market operations and standing facilities, net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) rose by EUR 2.5 billion to EUR 100.1 billion.

Base money (liability items 1, 2.1 and 2.2) decreased by EUR 29.4 billion to EUR 3,079.9 billion.

The table below provides the detailed breakdown of **securities held for monetary policy purposes** (asset item 7.1) into the different portfolios. All portfolios are accounted for at amortised cost.
