



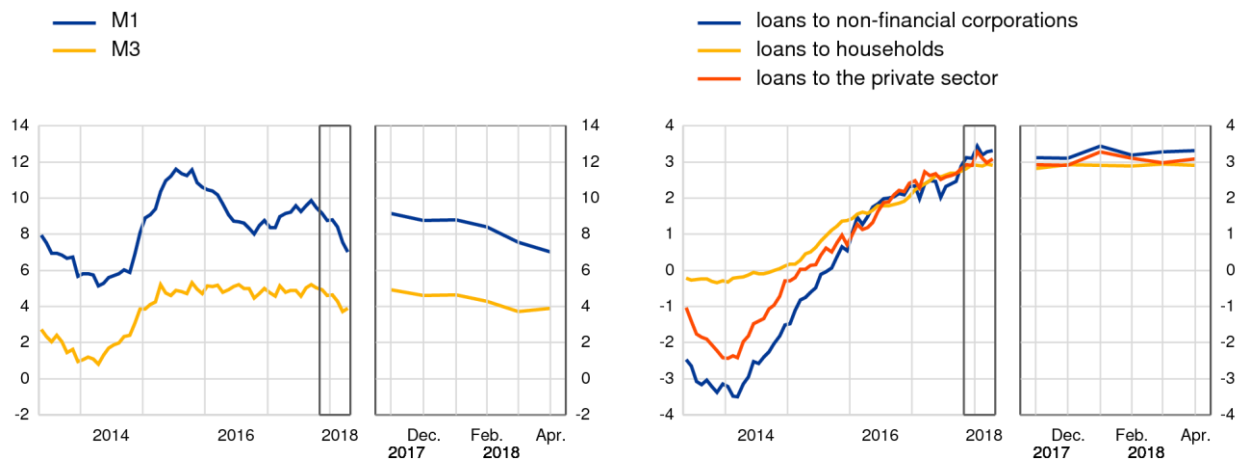

## Monetary developments in the euro area: April 2018

- The annual growth rate of the broad monetary aggregate M3 increased to 3.9% in April 2018, from 3.7% in March.
- The annual growth rate of the narrower aggregate M1, which includes currency in circulation and overnight deposits, decreased to 7.0% in April, from 7.5% in March.
- The annual growth rate of adjusted loans to households stood at 2.9% in April, unchanged from the previous month.
- The annual growth rate of adjusted loans to non-financial corporations stood at 3.3% in April, unchanged from the previous month.

### Components of the broad monetary aggregate M3

The annual growth rate of the broad monetary aggregate M3 increased to 3.9% in April 2018, from 3.7% in March, averaging 4.0% in the three months up to April. The components of M3 showed the following developments. The annual growth rate of the narrower aggregate, including currency in circulation and overnight deposits (M1), decreased to 7.0% in April, compared with 7.5% in March. The annual growth rate of short-term deposits other than overnight deposits (M2-M1) was -1.9% in April, compared with -2.1% in March. The annual growth rate of marketable instruments (M3-M2) was -0.6% in April, compared with -7.0% in March.

Within M3, the annual growth rate of deposits placed by households stood at 4.1% in April, compared with 4.0% in March, while the annual growth rate of deposits placed by non-financial corporations increased to

5.6% in April, from 5.3% in March. Finally, the annual growth rate of deposits placed by non-monetary financial corporations (excluding insurance corporations and pension funds) decreased to 1.7% in April, compared with 5.2% in March.

### Credit to euro area residents

The annual growth rate of total credit to euro area residents stood at 3.0% in April 2018, compared with 2.9% in the previous month. The annual growth rate of credit to general government decreased to 3.2% in April, compared with 3.9% in March, while the annual growth rate of credit to the private sector increased to 3.0% in April, from 2.6% in March.

The annual growth rate of adjusted loans to the private sector (i.e. adjusted for loan sales, securitisation and notional cash pooling) stood at 3.1% in April, compared with 3.0% in March. Among the borrowing sectors, the annual growth rate of adjusted loans to households stood at 2.9% in April, unchanged from the previous month, and the annual growth rate of adjusted loans to non-financial corporations stood at 3.3% in April, unchanged from the previous month.

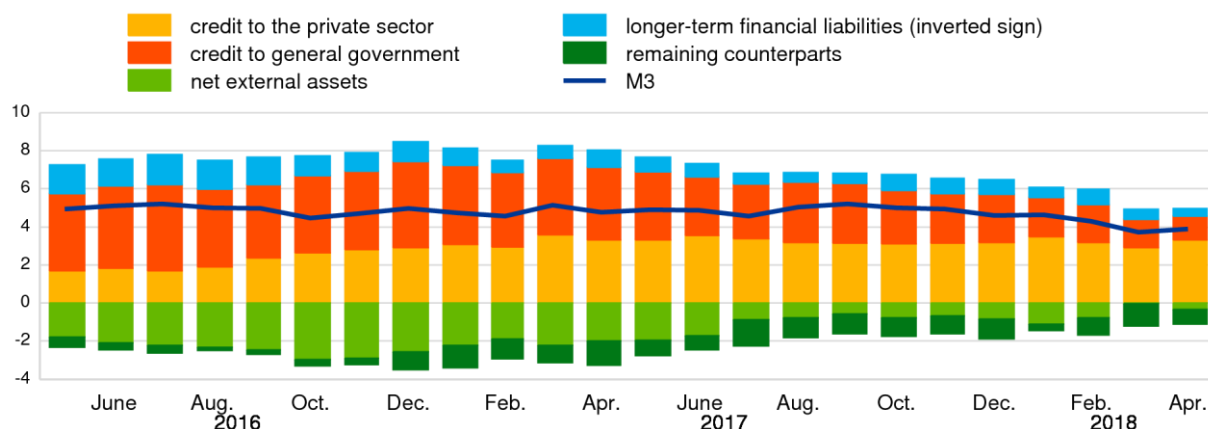
### Longer-term financial liabilities

The annual growth rate of longer-term financial liabilities of the MFI sector was -0.7% in April 2018, compared with -0.9% in March.

### M3 and its counterparts

The annual growth rate of the broad monetary aggregate M3 was 3.9% in April 2018. The contributions of M3 counterparts on the MFI balance sheet were as follows: longer-term financial liabilities contributed 0.4 percentage point, net external assets contributed -0.3 percentage point, credit to general government contributed 1.2 percentage points, and credit to the private sector contributed 3.3 percentage points; the remaining counterparts of M3 contributed -0.8 percentage point.
