Consolidated financial statement of the Eurosystem as at 12 July 2019

In the week ending 12 July 2019 **gold and gold receivables** (asset item 1) increased by EUR 2 million owing to the purchase of gold coin by two Eurosystem central banks.

The net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) decreased by EUR 0.1 billion to EUR 287.2 billion.

As a result of the Eurosystem's open market operations and standing facilities, net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) rose by EUR 0.8 billion to EUR 113.5 billion.

Base money (liability items 1, 2.1 and 2.2) decreased by EUR 24.2 billion to EUR 3,154.3 billion.

The table below provides the detailed breakdown of **securities held for monetary policy purposes** (asset item 7.1) into the different portfolios. All portfolios are accounted for at amortised cost.
