
Euro area bank interest rate statistics: June 2022

- Composite cost-of-borrowing indicator for <u>new loans to corporations</u> increased by 27 basis points to 1.82%, driven by the interest rate effect, while indicator for <u>new loans to households for house purchase</u> increased by 16 basis points to 1.94%, driven by the interest rate effect
- Composite interest rate for <u>new deposits with agreed maturity from corporations</u> increased by 14 basis points to -0.10%, driven by the interest rate effect, with interest rate for <u>overnight</u> <u>deposits from corporations</u> unchanged at -0.04%
- Composite interest rate for <u>new deposits with agreed maturity from households</u> broadly unchanged at 0.28%, with interest rate for <u>overnight deposits from households</u> unchanged at 0.01%

Data for cost of borrowing and deposit interest rates for corporations (Chart 1)

The composite cost-of-borrowing indicator, which combines interest rates on all loans to corporations, increased, driven by the interest rate effect in June 2022. The interest rate on new loans of over €1 million with a floating rate and an initial rate fixation period of up to three months increased by 67 basis points to 1.81%, mainly driven by the interest rate effect. The rate on new loans of the same size with an initial rate fixation period of over three months and up to one year rose by 32 basis points to 1.54%, mainly driven by the interest rate effect. The interest rate on new loans of over €1 million with an initial rate fixation period of over ten years increased by 19 basis points to 2.17%, driven by the interest rate effect. In the case of new loans of up to €250,000 with a floating rate and an initial rate fixation period of up to three months, the average rate charged stayed almost constant at 1.83%.

As regards new deposit agreements, the interest rate on deposits from corporations with an agreed maturity of up to one year rose by 13 basis points to -0.17% in June 2022, driven by the interest rate effect. The interest rate on overnight deposits from corporations stayed constant at -0.04%.

The interest rate on new loans to sole proprietors and unincorporated partnerships with a floating rate and an initial rate fixation period of up to one year decreased by 4 basis points to 2.15%, driven by the interest rate effect.



Data for cost of borrowing and deposit interest rate for households (Chart 2)

The composite cost-of-borrowing indicator, which combines interest rates on all loans to households for house purchase, increased, driven by the interest rate effect in June 2022. The interest rate on loans for house purchase with a floating rate and an initial rate fixation period of up to one year increased by 14 basis points to 1.66%, driven by the interest rate effect. The rate on housing loans with an initial rate fixation period of over one and up to five years rose by 16 basis points to 2.03%, mainly driven by the interest rate effect. The interest rate on loans for house purchase with an initial rate fixation period of over five and up to ten years increased by 21 basis points to 2.23%, driven by the interest rate effect. The rate on housing loans with an initial rate fixation period of over ten years rose by 12 basis points to 1.86%, driven by the interest rate effect. In the same period the interest rate on new loans to households for consumption decreased by 4 basis points to 5.57%, driven by the weight effect.

As regards new deposits from households, the interest rate on deposits with an agreed maturity of up to one year remained broadly unchanged at 0.19%. The rate on deposits redeemable at three months' notice and the one on overnight deposits from households stayed constant at 0.47% and 0.01%, respectively.

Press release / 2 August 2022 Euro area bank interest rate statistics: June 2022

Notes:

- Owing to technical issues at De Nederlandsche Bank, the production of June 2022 data for the Netherlands has been delayed. Euro area data for June 2022 in this press release therefore include estimates for the Netherlands based on data for May 2022. June 2022 data for the Netherlands will be published in the ECB Statistical Data Warehouse once the technical issues at De Nederlandsche Bank have been resolved.
- In this press release "corporations" refers to non-financial corporations (sector S.11 in the European System of Accounts 2010, or ESA 2010), "households" refers to households and non-profit institutions serving households (ESA 2010 sectors S.14 and S.15) and "banks" refers to monetary financial institutions except central banks and money market funds (ESA 2010 sectors S.122).
- The composite cost-of-borrowing indicators are described in the article entitled "Assessing the retail bank interest rate pass-through in the euro area at times of financial fragmentation" in the August 2013 issue of the ECB's Monthly Bulletin (see Box 1). For these indicators, a weighting scheme based on the 24-month moving averages of new business volumes has been applied, in order to filter out excessive monthly volatility. For this reason the developments in the composite cost of borrowing indicators in both tables cannot be explained by the month-onmonth changes in the displayed subcomponents. Furthermore, the table on bank interest rates for corporations presents a subset of the series used in the calculation of the cost of borrowing indicator.
- Interest rates on new business are weighted by the size of the individual agreements. This is done both by the reporting agents and when the national and euro area averages are computed. Thus changes in average euro area interest rates for new business reflect, in addition to changes in interest rates, changes in the weights of individual countries' new business for the instrument categories concerned. The "interest rate effect" and the "weight effect" presented in this press release are derived from the Bennet index, which allows month-on-month developments in euro area aggregate rates resulting from changes in individual country rates (the "interest rate effect") to be disentangled from those caused by changes in the weights of individual countries' contributions (the "weight effect"). Owing to rounding, the combined "interest rate effect" and the "weight effect" may not add up to the month-on-month developments in euro area aggregate rates.
- In addition to monthly euro area bank interest rate statistics for June 2022, this press release incorporates revisions to data for previous periods. Hyperlinks in the main body of the press release lead to data that may change with subsequent releases as a result of revisions. Unless otherwise indicated, these euro area statistics cover the EU Member States that had adopted the euro at the time to which the data relate.
- As of reference period December 2014, the sector classification applied to bank interest rates statistics is based on the European System of Accounts 2010 (ESA 2010). In accordance with the ESA 2010 classification and as opposed to ESA 95, the non-financial corporations sector (S.11) now excludes holding companies not engaged in management and similar captive financial institutions.
