Financial Education Day

The Banco de España and the National Securities Markets Commission (CNMV) renew the Financial Education Plan (2018-2021)

The Governor of the Banco de España, Luis M. Linde, the president of the CNMV, Sebastián Albella, the State Secretary for Economic Affairs and Competitiveness, Irene Garrido, and the State Secretary for Education, Vocational Training and Universities, Marcial Marín, have today hosted the Financial Education Day at the Banco de España's headquarters in Madrid.

The Governor of the Banco de España and the president of the CNMV have renewed the cooperation agreement entered into for the development of the Financial Education Plan over the next four years.

The Financial Education Day is an initiative promoted within the framework of the Financial Education Plan (FEP), sponsored by the Banco de España and the CNMV and in which numerous institutions are participating. This is the third edition of the event, which is held every year on the first Monday in October.

Today's event has included the final of the Financial Knowledge Prize, won by Al Satt Secondary School, from Algete (Madrid), and the awarding of the second edition of the "Finance for All" prize for the best financial education initiatives in Spain. The respective winners were Fundación Mapfre, for its promotion of insurance culture, and Fundación Isadora Duncan, for its personal finance programme for single-parent families.

Another initiative, which was a great success in previous editions, is the financial education hotline, set up on 900 54 54 54 (from 8:30 to 17:00, Monday to Friday), where members of the public can find help resolving any doubts they may have about managing their personal finances.

Alongside the CNMV and the Banco de España, the institutions taking part in the Financial Education Day include the Ministry of Economic Affairs and Competitiveness (through the General Secretariat of the Treasury and Financial Policy and the Directorate General of Insurance and Pension Funds), the Ministry of Education, Culture and Sport, educational and consumer associations, together with financial institutions, through their sector associations, foundations and other organisations.
