Promoted by the Banco de España and the CNMV

Prizes for the best Financial Education Day initiatives awarded

The Secretary of State for Economic Affairs and Business Support, Ana de la Cueva, the Secretary of State for Education and Vocational Training, Alejandro Tiana, the Governor of the Banco de España, Pablo Hernández de Cos, and the President of the CNMV (National Securities Market Commission), Sebastián Albella, have today chaired the main event of Financial Education Day at the CNMV's premises.

Financial Education Day is an initiative launched as part of the Financial Education Plan (FEP), promoted by the Banco de España and the CNMV, in which 29 institutions and entities are participating.

The aim behind this day is to boost financial education and to make society aware of its importance for the public at large, since it enables them to acquire the knowledge and skills needed to be able to manage their personal finances throughout their lives.

This is the fourth edition of the event, which always takes place on the first Monday of October.

The institutional representatives gathered at the CNMV concur on the need to boost financial education from the public sphere and on the importance of collaboration between government and the private sector in this field.

Today's event saw the final of the Financial Literacy Competition, won by the Santísima Trinidad school in Plasencia with the runner-up the San Francisco Javier (Jesuitas) school in Tudela. Also, the prizes for the third edition of the *Premio Finanzas para Todos* (Finance for All Prize) were awarded for the best financial education initiatives in Spain. The winners were "Finanzas para Mortales" ("Finance for Mortals"), for their promotion of financial education in Spain, and the BASES (Foundations) project by the Cooperativa de Maestros Melilla (Melilla teachers' cooperative), run at the Enrique Soler school, Melilla.

For the staging of Financial Education Day, a specific website – <http://www.diadelaeducacionfinanciera.es/> – has been designed. Here information can be

found on the activities (over two hundred) being conducted at present throughout Spain, with multiple financial education-related contents.
