## 1 Introduction

A census of Spanish non-banks identified as FinTechs is provided, obtained from various sources, mainly the Spanish Fintech and Insurtech Association (AEFI), Finnovating and the Spanish National Securities Market Commission (CNMV). The file contains just three variables: company name, trade name and Spanish tax identification number (NIF).

Based on the available accounting data of these firms, the set of microdata of Spanish non-banks identified as FinTechs has been drawn up. The main characteristics of this dataset are:

- a) Access to the financial statements of Spanish non-banks identified as FinTechs.
- b) Availability of identifying variables that permit characterisation of each firm.
- c) Over 100 corporate accounting variables and over 80 national accounting variables.
- d) Historical time series since 2018.
- e) Over 200 firms.
- f) Output data in .csv format.

## 2 Description of dataset

Some of the characteristics of the dataset are set out below in schematic form.

Indicators are provided that allow filters to be applied where necessary.</li></ul>

<b>Original data cleansing and processing</b>	<p>Researchers accessing FinTechs must be aware that the data available may not coincide with the basic variables reported by firms in their original official information. The CBSO applies data cleansing in an endeavour to grant coherence and stability to the historical time series.</p> <p>Compared to previous years, there has been a significant change in the treatment of fintech companies included in the financial sector: the net amount of turnover does not include any income that can be considered financial in nature. This change in approach has been applied to all the years that make up the current set of information.</p> <p>Although the source data are public data, the cleansing and adjustments made to the original data mean that the final output of the research project should avoid any direct or indirect identification of individual firm-level data.</p>
<b>Data format</b>	<ul style="list-style-type: none"> <li>- Files in .csv format.</li> <li>- A distinction is made in the data between a variable that takes the value '0' and a missing variable (blank).</li> <li>- By default, all available variables are provided and it is for researchers to decide whether or not to use them in their work.</li> </ul>
