#### Motivation

The first issuance of a green bond by a Treasury took place in December 2016 and the number of countries, regions and supranational institutions issuing green bonds and other types of sustainable debt are increasing. This workshop contributes to sharing their challenges, as well as the key elements for assessing the climate change and sustainability aspects of sovereign bonds.

Sovereign green bonds are attracting increasing interest from institutional investors, including central banks which are integrating sustainable and responsible investment principles into the frameworks for the management of its own portfolios. For example, Banco de España published its first report on <u>Climaterelated aspects of Banco España's non-monetary policy portfolios</u> in 2023 and more detailed information is included in the document published last week, which is being presented today.
